Moorestown Township Public Schools MooreNet Acceptable Use - Students



Moorestown Township Public Schools (MTPS) is pleased to offer MTPS students access to the district computer network and its associated Internet resources (MooreNet). To obtain a MooreNet account and use these resources, students must obtain parent/guardian permission and return a signed MooreNet Acceptable Use Agreement/Permission Form (attached). Parents/guardians please read this document carefully, review its contents with your son/daughter, and sign and date the attached MooreNet Acceptable Use Agreement/Permission Form as appropriate. Any questions or concerns regarding student access to MooreNet should be referred to your school's Library/Media Specialist. The complete version of the MTPS School Board policy (Policy 2361 - Acceptable Use of Computer Networks/Computers and Resources) and a copy of this document are available on the Moorestown Township Public Schools web site, www.mtps.com.

General Network Use

MooreNet consists of the computers, networks, and software systems that facilitate access to local and Internet resources. MooreNet also includes MTPS-administered "cloud-based" Internet services such as MTPS's G Suite for Education. MooreNet is provided for students to conduct research, complete assignments, store information, and communicate with others. Access to MooreNet is given to students who agree to act in a responsible, ethical and legal manner. Access is a privilege not a right. As such, general school rules for behavior and communications apply and users must comply with district standards. Data storage systems will be treated like school lockers; users should not expect that files stored on MTPS-provided systems will be private.

Responsibilities Regarding MooreNet

Moorestown Township Public Schools will provide access to and integrate a thoughtful use of MooreNet throughout the curriculum and will provide guidance and instruction in the appropriate use of such materials in a learning community. Access to the Internet (and at certain grade levels, e-mail) will enable students to use thousands of libraries and databases. Within reason, freedom of speech and access to information will be honored, but may be restricted if the learning environment is disturbed by a student's speech.

In general, electronic traffic passes freely in a trusting atmosphere with a minimum of constraints. However, families should be warned that some material accessible via the Internet might contain items that are illegal, defamatory, inaccurate or potentially offensive. While our intent is to make Internet access available to further educational goals and objectives, students may find ways to access other materials as well. Filtering systems are used, but no filtering system is capable of blocking 100% of the inappropriate material available on the Internet. Ultimately, parents and guardians of minors are responsible for setting and conveying the general standards that their children should follow when using media and information sources.

Google G Suite For Education Service

MTPS uses a "Google G Suite for Education" service that includes student email, collaborative documents, and other functionality. An email address may be assigned to the student and used for the purpose of collaboration and communication between students and between students and staff. MTPS will utilize services and practices to filter and manage email and web content security, although no system is infallible. Use of MTPS's G Suite system falls under the terms of MTPS Policy, this Acceptable Use agreement, and Google's rules for use of their systems.

Other Online Services

MTPS may allow students to utilize other online services for accessing educational content, which may include, but is not limited to, Gynzy, Socrative, Edmodo, and others. For a more complete listing: MTPS Approved Software/Services List. Students agree to adhere to the terms of service of those systems and parents authorize their student to utilize those services.

Rights and Privileges

The network services are provided for educationally-related communication, research and other activities.

- Students will submit a signed Acceptable Use Agreement, including parental/guardian permission, to the appropriate school personnel.
- Accounts will be issued, including a username and password, assuring that appropriate access (including log-ins and log-offs) is the responsibility of the student.
- Each student granted access shall be assigned storage space within the MooreNet systems which will be treated like school lockers.
- Network security is designed to allow access to these spaces only by the
 assigned user; however, authorized MTPS staff members may review
 files, communications, history, websites accessed, etc. to maintain system
 integrity and ensure that users are using the system responsibly.
- Users should not expect that files stored on district resources will be private.

Unacceptable Uses of MooreNet

The MooreNet account holder is held responsible for his/her actions and activity within his/her account. Unacceptable uses of MooreNet include, but are not limited to, the following:

- Damaging computers, computer systems or computer networks; vandalizing, damaging or disabling the property of another person or organization; debilitating or disabling computers, systems or networks through the intentional misuse or overuse of electronic distribution or storage space, or the spreading of computer "viruses" through the inappropriate use of files or storage devices.
- Accessing, uploading, downloading, transmitting or displaying or distributing obscene or sexually explicit material; transmitting obscene, abusive or sexually explicit language.
- Storing and/or installing any software programs not owned by or licensed to MTPS or the school on any MooreNet resources. This includes "freeware" or "shareware" programs as well as commercial software, with the exception of class work for school programming classes.
- Violating copyright or otherwise using another person's intellectual property without his or her prior approval or proper citation.
- Gaining or seeking unauthorized access to another person's or entity's accounts, resources, folders, work or files.
- Forging electronic messages, posting anonymous messages and/or posting messages that are harassing, insulting or attacking others.
- Giving personal information about himself/herself or others, including but not limited to: full name, phone number, address or identifiable photo.
- Employing the network for commercial purposes, financial gain, or fraud.
- Violating local, state or federal statute.

Sanctions / Consequences

Disciplinary action related to student access to electronic resources may be determined at the building and/or classroom level in accordance with existing practice regarding inappropriate language or behavior, as stated in policies and guidelines contained in the pertinent building student handbook.

- Violations of the school and/or MooreNet acceptable use policies may result in restricted access, or a loss of access, to electronic resources.
- Additional sanctions for inappropriate behavior and communication shall be governed by existing practice and board policy, and may include, but not be limited to, damages and reimbursement for system and program repair/replacement.
- When appropriate, law enforcement agencies may be involved.

- The staff, the school and MTPS are not responsible for any damages incurred, including, but not limited to, loss of data resulting from delays or interruption of service, for the loss of data stored on MooreNet resources, or for personal property used to access MooreNet resources.
- MTPS will not be responsible for the accuracy, nature, or quality of information stored on MooreNet resources or accessed through districtprovided resources.
- MTPS will not be responsible for unauthorized financial obligations resulting from use of district-provided access.
- Further, even though MTPS may use technical or manual means to regulate access and information, these methods do not provide a foolproof means for enforcing the provisions of this agreement or Board policy.
