Level: 4 Grades: 10-12 5 Credits/Year

Honors Spanish 4 refines grammar skills already learned and stresses a broad and diversified use of language skills on a more advanced level. Current events are used to develop oral competence, a major goal of the course. Students engage in sustained conversations and read authentic literature. The reading selections form the basis for oral and written composition. Students should consider taking the SAT II test upon completion of this course.

Prerequisite: Successful completion of Honors Spanish III with a final minimum grade of C.

They use increasingly complex vocabulary and structures, compare points of view and perspectives, and write or speak original pieces such as essays, stories, and poems. Intermediate High learners demonstrate evidence of Advanced Low proficiency but lack consistency in maintaining the advanced level.
