Course Description and Fundamental Concepts

In this course, 6th grade students will pursue a study of the Spanish language at the Novice-mid level. The class will meet twice per 8 day schedule for a 54 minute class period. Students will work in the Interpretive, Interpersonal and Presentational modes and focus on both Communication and Culture. Students will utilize technology for both research and performance tasks.

They have no real functional abilities and, therefore, cannot participate in true exchanges of information.
