# **Course Description and Fundamental Concepts**

In this course, 6<sup>th</sup> grade students will pursue a study of the Spanish language at the Novice-mid level. The class will meet twice per 8 day schedule for a 54 minute class period. Students will work in the Interpretive, Interpersonal and Presentational modes and focus on both Communication and Culture. Students will utilize technology for both research and performance tasks.
