Course Description and Fundamental Concepts

This course prepares students to take the AP Latin exam. It is an extremely rigorous course that follows the entire AP Latin syllabus. Students will focus on translation and analysis of Vergil's *Aeneid* and Caesar's *De Bello Gallico*, the historical, cultural, and political contexts of each work, the ability to read Latin at sight, poetic scansion and meter, literary devices, and more advanced grammar and vocabulary. At the end of the year students will also study Roman comedy through the works of Plautus and Terence.

AP Course Objectives:

- The student reads and comprehends Latin poetry and prose with appropriate assistance.
- The student translates previously prepared Latin texts into English as literally as possible.
- The student relates the Latin texts to Roman historical, cultural, and literary contexts.
- The student analyzes linguistic and literary features of one or more Latin texts.
