favor hi thank you uh and we're gonna switch it up a

little bit and we're g to start with our student board representative so thank 6:54

you two weeks ago on November 29th the high school sent 12 students two staff 7:00

members and vice principal kunard uh to the Anti-Defamation League student leadership conference at the Philly

7:06

Convention Center our delegation represented a diverse group of students consisting of six Juniors including

7:13

myself and six sophomores and also Sophia um uh when we got there we listened to a holocaust Survivor tell

7:20

her story to all of us I thought it was important to listen to her story because it warned us of the devastating effects

7:25

of hate gone rampant from the start the convention sent us a clear message to spread to our fellow students and I

7:31

thought that speaker did a really good job of establishing that next we all got into breakout groups with people that we

7:37

did not know in these breakout groups we discussed the effect that bullying had on people's lives we began to think

7:43

about what seemingly harmless words could do to a person after that we moved to discuss our findings with people from

7:49

our school we talked about ways that we could help stop buling discourage bystanding and convince more people to

7:55

stand up for their fellow students we focused on the fact that our school is so divided into their own separate

8:01

groups uh we noticed that most of our school spirit events the events that are supposed to unify really just involve

8:08

competitions that divide um we thought that we could Foster a sense of 8:14

community and create up standards by having more events to unify the school this would allow people to meet new

8:20

students outside of their circles um unify the different groups in

8:26

school and by having a sense of community get more people stand up to bullying even when it's someone that

they just don't know overall I think it was a really valuable experience for me and everyone else on the trip and I

8:38

think we learned lessons that we just can't wait to share with our school

8:45

Community great thank you hi I'm Sophia baram and I am the

8:52

sophomore class liaison but I'll also be speaking for the freshman and senior class liaison so em MHS we have a really

9:00

good arts program and this winter we're having all our winter concerts last week was the chorus concert featuring concert

9:08

choir and just regular Ensemble and then next week we have our combined Orchestra and band Winter concert featuring

9:15

orchestra band and then jazz band and then one thing that our school has 9:20

coming up after break is our love fair this fair is during 14th period after school and was a huge success last year

9:28

which was also our first you're doing it the Love Fair is a community service fair in the cafeteria that connects

9:34

students to local nonprofits where they can do community service for clubs can also in the school

9:42

also come to the fair to share ways to get involved it also helps people get excited for the upcoming Martin Luther

9:48

King Day assembly and this year's Love Fair is scheduled to be January 17th after break and planning for it has

9:54

started this week and then in terms of the mlks assembly our Martin Luther King 10:00

Day assembly is to celebrate and honor Dr King as a great leader in the Civil Rights Movement leading up to the

10:07

assembly the video production Club works with student council to make a video for the assembly about Dr King's life which

10:14

also is helped by a research committee that spends a bunch of time right here in the library researching things for

10:20

his life to put in the video there's also PR committee which helps publicize the the assembly in love fair to get

students excited about it and for the assembly theirself the choir usually sings songs the magical and last year we

10:34

also had representatives from unity in their Community to speak thank 10:44

you great thank you both for joining us tonight you're certainly welcome to stay if you'd like but please don't feel

10:49

obligated and you can take off whenever you'd like and uh with that I will pass 10:54

it off to Mr bandor for the superintendent report

all right so the one night I have to get up and speak gotta be trapped behind here so it's all good but I'm out um I

11:26

have a couple of things that I want to review tonight I'll start with the heavy thing first and then uh something very special second um I

11:33

wanted to review for the purpose of the community uh our events of Last Friday I know I sent a a letter to the community

11:39

and I know the ve the letters don't answer all the questions and quite frankly some of the questions that needed to be answered weren't answered

11:45

yet when that letter went out the most important message that we wanted to send it was everything was okay and I can't

11:51

tell you what a relief those things are know you're sitting in your office and you're hearing the worst case scenario

11:59

um you immediately leap into action um and essentially what we're dealing with is we um found out that our alarm

12:07

company had been testing our alarms at about 12 o'clock every single day and 12:13

the alarms are not on Wi-Fi they're running on copper old copper telephone wire and there was a cross in the signal

12:20

and It produced a an error message that then produced a text message that went 12:25

out to a lot of people in the community including our police force and many members of our administrative team that

12:32

there was an active shooter at an address which was 210 South Valley I 12:39

mean not South Valley 210 South Stanwick I apologize um now for somebody like me who is not that familiar with the

12:45

dresses in town I didn't know off the top of my head where 210 um Stanwick was 12:51

and it occurred to me that this is not a good thing that we should have an address and we should have the name of a

12:56

school it's the reason why the high school went into a lock down because upon seeing Stanwick on the messages

13:01

that they got we have two buildings connected to them on this campus that have Stanwick addresses so they not

13:08

knowing did the right thing and went into a lockdown but other buildings didn't get the message at all so we

13:15

learned a lot that day about things that need to be corrected um that are being 13:21

corrected we're working very actively we had it diagnosed that day by that company and uh we are as in any it's

13:29

been my experience that whenever an emergency of any sort occurs whether it's a you know a threat a bomb scare a

13:35

fire whatever it may be something always comes out of those events that helps us do better what I would what I did try to

13:43

convey in that letter and I did not want that to be mistaken in any way shape or form that we were making um happiness

13:51

out of that event to say that um the actions of people were absolutely

13:57

appropriate and on point what the staff did down at South Valley with their kids 14:02

and how they handled that scenario was amazing the most important thing I know the kids really didn't know as most

14:09

people didn't know what the alert was about so they were just following the fact that we drill and we do all these

14:15

things they were doing exactly what they've been trained to do and they did it exceptionally well the other great

14:20

piece that came out of that is the police response was enormous and quick and they were ready to go and do their

jobs that was an amazing thing to see and as somebody who thinks about these things all the time as the worst case

14:33

scenario um it was comforting to know that our people of action are going to 14:39

be there when we need them they were very complimentary as well as to how it was handled by the staff and the things

14:45

that were done that day um but please rest assured in this community we are taking it very seriously we are looking

14:51

at it I consider myself very much a security-minded superintendent uh we've already done

14:58

much in that area and continue to do more and uh you know we will uh correct 15:04

those mistakes that occurred on that day we will move forward and we will be better for it so I wanted to assure

15:10

people and naturally if you have questions when the open public comment comes and you want to ask anything more that I didn't cover please do so I'm

15:16

obviously doing this off the top of my head but I appreciate the support I got some really nice emails from our parents

15:22

in the community which I appreciate it uh but know that we're working every day to continue to make things safe for our

15:27

kids and for our staff and for our community so with that I want to follow that up with something very positive

me now before I spoke speak specifically about you I want to say a few things so tonight is uh Lauren

Romano's last board meeting she's been serving the board for six years I think that's pretty amazing considering the

of America run and Lauren you have done an exceptional job the fact that you are a fellow educator brings a unique

there was an update that all was okay and that it was um it there there was no 20:25

serious uh incident underway and I think that the way that the administration and the principles handled it was uh was

very well done and so I appreciate uh all of your work and everybody's work 20:38

during a very stressful time that thankfully turned out to um be a drill 20:44

for lack of a better word and it it gave us notice of things that we can improve 20:49

upon but also um give us confidence that the response was appropriate and thank you to the township uh and the police

20:55

department for their prompt response because as I understand they were there and our SOS were there um on

a moment's notice um so that can give us some confidence that in the event that there is a need that that we are

21:09

prepared to respond um moving on to the board

more information about that will be coming in uh the next few months um and 22:42

then lastly uh Dr Benton gave an overview um of the budget development um 22:50

focus um for in uh Focus areas for curriculum and instruction for 2024

budget um the main goals will be the k through eight math curriculum implementation that will be a big ticket

23:03

item um that as we're piloting um the programs for this year um that will need 23:08

to uh be budgeted for future um implementation um also then

23:15

continued as we've looked at quite a bit in curriculum uh multi-tiered systems of support um implementation for support

23:23

for our struggling Learners so how we're going to continue to provide the budget report for that um is a goal and then

23:30

lastly there was as I mentioned at last month's meeting a new set of 2023 Ela 23:36

and math standards and some of the supplemental curriculum adjustments that will need to be um purchased to meet

23:43

those standards in the New Year and that was our

23:48

meeting thank you any questions for Lauren all right next finance and 23:55

operations Mick sure thank you Mark so uh we met December 5th earlier this week 24:03

so I attended along with Cheryl mccoist Daniel Miller Claudia Moreno from the board Administration included Joe

24:09

Bendorf James Heiser Haron Benton Jeff Ary and Carol Butler we started off uh

similarly to curriculum with a discussion about our section of

qac uh that also included an update to the standard operating procedure document that needs to be there as part

of qac we reviewed uh the matrices for the review of rfps that were submitted 24:35

for architect auditor broker of record and bond counsel so James shared those

matricies with us and uh gave us the recommendations the results of that 24:48

would be shared uh at each committee meeting there's also an ongoing process that Carol Butler is leading that is

revising all of the job descriptions to make sure they adhere to a set of Standards U and also updating them to

make sure that they're aligned with what those positions are currently doing so we reviewed three six nine 12 of those

um and then talked specifically about how some of those will be implemented a few changes in the IT department that Mr AR walked us through talking about um 25:20

replacing uh people that are retiring with potentially uh shift in in

25:26

responsibilities um and just how that will all line up and

25:31

then um we'll continue to review job descriptions at committee meetings over 25:37

the next several months to ensure that they've all been reviewed by the Board of Education by June of 2024 we actually

25:43

didn't have any uh items under the discussion or miscellaneous business or future items so that was a relatively

25:51

short meeting for finance and operations so any

25:56

questions no the mic so all right next up policy Claudine yes

uh policy committee met on December 8th in attendance from the board was myself 26:09

Melissa AR Burns Joe fellos Macaluso and mark banua from the administration was Mr bandorf and Dr Benton um you'll see

on first reading uh for this board meeting we have a package of policies that address our interaction with um the

26:26

independent and community-based organizations and boosters um that interact with the district uh this has

26:33

been a long process that predates many of us on the board and includes probably 26:38

Lauren over the years uh these policies are very important because they involve 26:43

valued entities that are important to the district um we've seen uh these 26:49

policies evolve over time and be amended to the point where you know compliance 26:55

and understanding of them um needed to to be um they need to be cleaned up 27:00

basically so we took that on earlier this year it's been about a year-long process we put the necessary time and

27:07

attention into it because this these are these are quite important um to the district none of these are mandatory

27:13

we're choosing to obviously maintain these policies but I did want to just run through um some of them briefly so

27:21

policy number 9190 which is on first reading is uh would involve our 27:26

community organiz ations it is an amendment to an existing policy this 27:32

policy previously was a catchall section which captured pretty much every type of 27:37

organization that we interacted with from school clubs to booster clubs to Township clubs um so we've reduced this

27:45

community organization to really what it was intended to was engaging and giving Authority and permission and direction

27:51

to our superintendent to voluntarily engage with the community um any 27:57

organization that he feels would enhance the educational and experience of the of the district um the 91 90.1 is a brand

28:07

new policy and it is called educational foundations so we do not currently have 28:13

a policy um that something like MEF or more Arts would fall into to know how to 28:19

interact with the district so 91 90.1 will take care of that

28:26

9191 is our booster policy and while boosters were already falling under the 28:32

original Community organization um we moved it into its own unique policy um we captured a lot of

28:39

the original language in here but made some some tweaks as well and 9210 is our 28:45

parent organization this is just also an amended version um this is kind of where 28:51

uh home and school um uh would would fall under as well as um just just home 28:57

school will probably likely fall under here sorry um in doing this it really would give 29:06

the these organizations more Direction and how to interact with the district um whether it's use of our facilities uh

29:13

volunteering donations um asking for permissions to use our logos um getting endorsements or

29:21

sponsorship um with the district it gives a little bit more Comfort on the organization's part that they're doing

29:27

the right thing and it gives the superintendent and the administration the ability to monitor the activities

29:33

you know happening within the the district so with that said on second 29:39

reading we have our school thread assessment teams which is a new policy it's mandatory um it was approved on

29:45

first reading last month and items for discussion we also had our qac presentation um and we also had a very

29:54

brief discussion on our next Frontier which would be be tackling our um high school and um substance abuse policies

30:02

uh very long uh involved policy with a lot of statutory requirements so we're going to take some time to review that

30:08

and uh make some changes Mark all right um I'll only note I think 30:16

uh for those that may not be familiar the way that our policy approval process works is uh we have two readings so um

at tonight's meeting there are this Suite of community organization policies that are on for first reading that

30:31

doesn't mean that they are effective um yet and so there's an opportunity to 30:36

review get community feedback on these policies um and looking at them earlier I've noticed that there's a couple

30:42

tweaks um like typo type of things uh that certainly need will be addressed before uh the policies are put up for

they will be up for second reading uh most likely at our first formal board 31:03
