Jazz Band

This course is designed for the instrumentalist interested in discovering and performing jazz music. Basic blues chorale patterns, blues scales, swing patterns and standards will be introduced to the ensemble. The instrumentation will be the standard jazz band form of the following: two (2) alto saxes, two (2) tenor saxes, one (1) baritone sax, five (5) trumpets, four (4) trombones, one (1) rhythm guitar, one (1) bass guitar, two (2) percussionists, and use only two (2) piano/keyboards.

Pacing Guide (All Dates are approximate based on the school calendar)

Due to the nature of an instrumental music course, skill building and content learning will be addressed in every rehearsal throughout the course of the year. As with any performing art form, instrumental performance is holistic and requires that concepts be reviewed and compounded on consistently in order for skill development and mastery to occur.
