## Course Description and Fundamental Concepts

### **Advanced Placement Studio Art 2D**

**A14-35**

**Grades: 11-12**

**6 Credits/Year**

Through studio practice students will compile a body of work, which demonstrates mastery of composition, concept, and execution to be submitted to the College Board for grading and possible college credit. A year long course of six periods (three double periods per week), affords students the opportunity to produce works of art that possess unique visual expression through the skillful manipulation of tools and the innovative use of techniques and materials, both traditional and contemporary in all three submission categories, (Selected Works, Sustained Investigation, Writing) of the College Board Drawing Portfolio. Within the drawing studio course students will each produce a minimum of 15 works of art to be submitted to the AP Art and Design/Drawing Portfolio to satisfy the requirements of Sustained Investigation and Selected Works. Along with each work, students are required to submit written responses to prompts about the work. Responses to these prompts are evaluated along with the images that the students submit.

Prerequisite: Successful completion of Fine Arts I, Fine Arts II, and Honors Studio.
