[Course Description and Fundamental Concepts](#)

Honors Portfolio Digital is a full-year course that further develops visual design skills using hands-on methods, photography skills, and Adobe web design tools. These industry-standard software skills will be used to develop Information and Communication Technology (ITC) skills in web design and production use. Students will gain experience in web and multimedia development. Project-based learning will enhance student portfolios that culminate in numerous digital communication skills including design, communication, project management, and web technology.

- Fundamental Concepts
 - Digital: develop skills to create original digital works of art and design with a focus on cohesive multi-part projects and a mastery of applying the elements and principles of art and design.
 - Print: develop an understanding of how to turn digital work into a physical product, with a focus on printing methods, craftsmanship, and presentation.
 - Multimedia formats: web and animation formats will combine traditional and digital creations with a focus on the user experience and project management
 - Independent portfolio: using original work created already, as well as a required amount of new work, students will apply skills to create a digital portfolio showcasing individual growth as an artist and personal expression.
